
As we look to the future, our intention is clear. We will continue to serve our nonprofit partners, improve on our services, and further our reach to create a positive impact that will endure for generations to come.

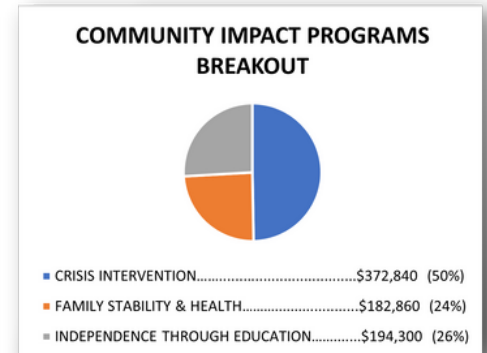
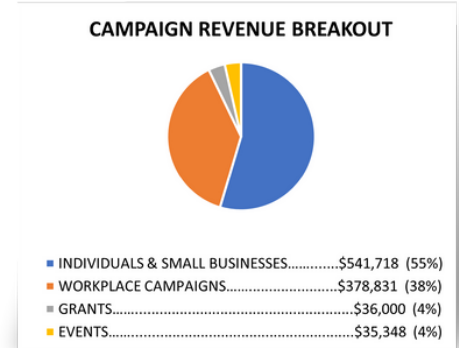
